

# Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to vsfunded.com, and governs data collection and usage.

VS Funded website is an eCommerce site. By using VS Funded website, you consent to the data practices described in this Statement and all extensions and addendums to this Statement.

## Collection of your Personal Information

In order to better provide you with products and services offered, VS Funded may collect personally identifiable information, such as your:

- First and Last Name
- Home Address
- Mailing Address
- E-mail Address
- Phone Number
- Financial Information

If you purchase VS Funded products and services, we collect billing and credit card information. This information is used to complete the purchase transaction or issue payments to you. We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services. These may include: (a) registering for an account; (b) entering a sweepstake or contest sponsored by us or one of our partners; (c) signing up for special offers from selected third parties; (d) sending us an email message; (e) submitting your credit card or other payment information when ordering and purchasing products and services. To wit, we will use your information for, but not limited to, communicating with you in relation to services and/or products you have requested from us. We also may gather additional personal or non-personal information in the future for the same purpose.

## Use of your Personal Information

VS Funded collects and uses your personal information to operate and deliver the services you have requested. VS Funded may also use your personally identifiable information to inform you of other products or services available from VS Funded and its affiliates.

## Sharing Information with Third Parties

VS Funded may sell, rent, or lease customer information to third parties for the following reasons: We will collect this data and provide it to third parties if it is a necessary step in the User account creation process, contributes to the ease of use, reliability, or functionality of our products, or if it is of mutual interest to VS Funded. VS Funded may, from time to time,

contact you on behalf of external business partners about a particular offering that may be of interest to you. In those cases, your unique personally identifiable information (e-mail, name, address, telephone number) is transferred to the third party. VS Funded may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to VS Funded, and they are required to maintain the confidentiality of your information. VS Funded may disclose your personal information, without notice, if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on VS Funded or the Site; (b) protect and defend the rights or property of VS Funded; and/or (c) act under exigent circumstances to protect the personal safety of users of VS Funded, or the public.

## **Tracking User Behavior**

VS Funded may keep track of the websites and pages our users visit within VS Funded, in order to determine what VS Funded services are the most popular. This data is used to deliver customized content and advertising within VS Funded to customers whose behavior indicates that they are interested in a particular subject area.

## **Automatically Collected Information**

Information about your computer hardware and software may be automatically collected by VS Funded. This information can include your IP address, browser type, domain names, access times, and referring website addresses. This information is used for the operation of services, to maintain the quality of the service, and to provide general statistics regarding the use of the VS Funded website.

## **Use of Cookies**

VS Funded website may use cookies to help you personalize your online experience. A cookie is a text file that is placed on your hard disk by a web page server. Cookies cannot be used to run programs or deliver viruses to your computer. Cookies are uniquely assigned to you and can only be read by a web server in the domain that issued the cookie to you. One of the primary purposes of cookies is to provide a convenience feature to save you time. The purpose of a cookie is to tell the Web server that you have returned to a specific page. For example, if you personalize VS Funded pages, or register with VS Funded site or services, a cookie helps VS Funded to recall your specific information on subsequent visits. This simplifies the process of recording your personal information, such as billing addresses, shipping addresses, and so on. When you return to the same VS Funded website, the information you previously provided can be retrieved, so you can easily use VS Funded features that you customized. You have the ability to accept or decline cookies. Most Web browsers automatically accept cookies, but you can usually modify your browser setting to decline cookies if you prefer.
